## Issue 12 – Substitute Levy – March 15 NO NEW TAXES FOR YOU

Substitute levies collect nothing extra from existing property owners but allow schools to capture a small amount of tax revenue from new construction.

In 2011, Jackson voters approved a Substitute Levy for the first time. That levy expires at the end of 2016. On March 15, Jackson voters will be asked to approve the 5-year measure for the exact amount of the expiring levy.

### Here's how it works

1. In the first collection year of the levy, the district receives the exact dollar amount that was generated by the expired levy. **No new taxes for you.**

2. In years 2-5, there are still **no new taxes** for existing property owners, but the district receives a small portion of the taxes generated by any of the township's new commercial or residential construction.



The Substitute Levy generates the same dollar amount that the expiring levy had generated.



Taxes on new homes and businesses built in year 1 are added to the levy base, allowing your schools to benefit from the growth.



Taxes on new homes and businesses built in years 2-5 are added to the levy base, allowing your schools to benefit from the growth.

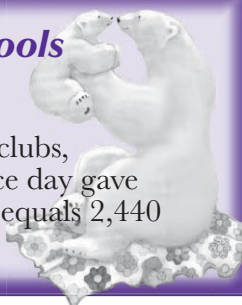

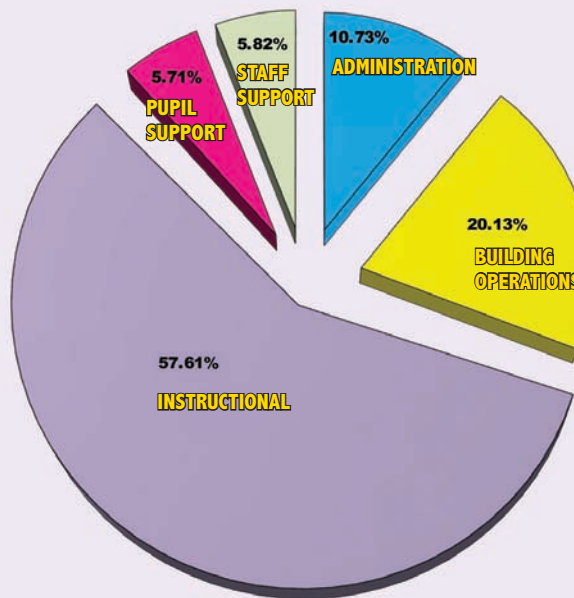

## 2013-14 EXPENDITURE PER PUPIL



**Administration** - Covers costs associated with the day-to-day operation of the school buildings and the central offices as far as administrative personnel and functions are concerned.

**Building/Operations** - Covers all items of expenditure relating to the operation of the school buildings and central offices. These include the costs of utilities and the maintenance and the upkeep of physical buildings.

**Instructional** - Includes all the costs associated with the actual service of instructional delivery to the students. These items strictly apply to the school buildings. They include the salaries and benefits of the teaching personnel and the other instructional expenses.

**Pupil Support** - Includes expenses associated with the provision of services other than instructional that enhance the developmental processes of the students. These cover a range of activities such as student counseling, psychological services, health services, social work services etc.

**Staff Support** - Includes all the costs associated with the provision of support services to school districts' staff. These include in-service programs, instructional improvement services, meetings, payments for additional trainings and courses to improve staff effectiveness and productivity.

**A majority affirmative vote is necessary for passage.**

Shall a tax levy substituting for an existing levy be imposed by the Jackson Local School District for the purpose of providing for necessary requirements of the school district in the initial sum of \$8, 560, 200, and a levy of taxes be made outside of the ten-mill limitation established by the county auditor to require 6.8 mills for each one dollar of valuation, which amounts to 68 cents for each one hundred dollars of valuation for the initial year of the tax, for a period of five years, commencing in 2016, first due in calendar year 2017, with the sum of such tax to increase only if and as new land or real property improvements not previously taxed by the school district are added to its tax list.

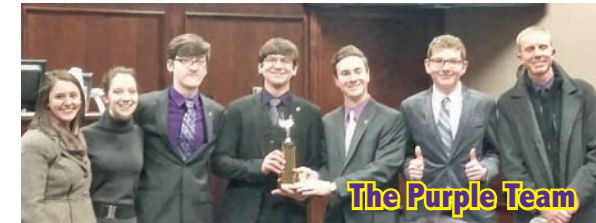

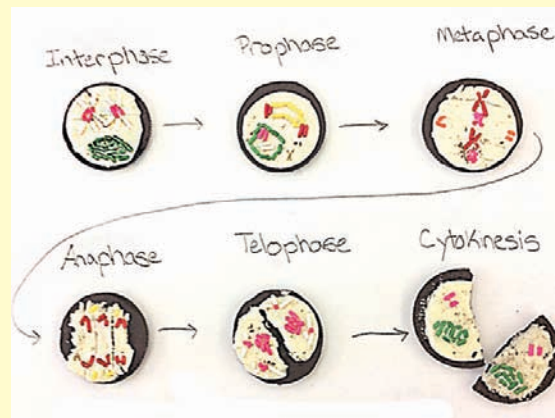

### JACKSON STUDENT LOAN ASSOCIATION

The Jackson Student Loan Association was established to provide low-interest student loans to JHS graduates who have been accepted by a post-secondary school (vocational, two-year or four-year).

Graduates may request up to \$5,000. The loan accrues no interest until a student's education is complete or he/she withdraws. Upon graduation or withdrawal, the note will bear interest on the unpaid balance at the rate commensurate with the Stafford Loan rate on the date the loan agreement was signed.

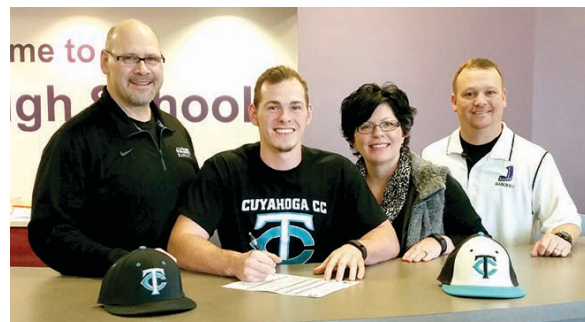
## Federal League Champs

The first Polar Bear Mascot bounded onto the Fife Stadium field in 1960, wearing a suit of authentic polar bear fur, head and all. It was worn by then senior, Lawrence Coltrin.

Students, teachers and booster clubs purchased a bear rug at a cost of \$225 from the H.O. Hoffman Company in Brooklyn, New York, and it was fashioned into a one-piece, wearable mascot suit by local

seamstress, Esther Hodgson who lined it with soft fabric and installed a zipper in the front.

The mascot was called Jack until a contest was held and the name Jay-Bee was selected.

The original bear skin was worn until the 1970s. The current mascot suit is made of synthetic fur.
