PAYMENT METHODS:

REFUND POLICIES:

The initial deposit is Non-Refundable. The balance refund policy is as follows:

Cancellation 29+ days from departure - Amount paid less Deposit.

Cancellation 0 -28 days- \$50 refund.

Traveling Classrooms will issue tour vouchers for all participants if the tour is rescheduled due to conditions beyond its control. If school cancels the trip after May 23rd, Traveling Classrooms will retain \$50 per student. All other payments will be refunded pending pre-paid vendor refunds to Traveling Classrooms.

NOTICE:

All school fees/fines must be paid before September 12, 2025 to be eligible to go on the field trip.

REMOVAL FROM TRIP:

Students removed from the trip for any reason will follow the refund policies listed above. Students may also be removed due to other guidelines listed on the <u>Parent/Student Agreement</u>. The following is a list of behaviors that may deem a student ineligible for participation. Please read over the list and be aware of the consequences of chosen behaviors:

- Any student who is no longer enrolled in or attending classes full-time (5 days a week) at JMMS.
- Any student who is expelled from or suspended out of school during the first nine weeks of 25-26 school year or second semester of the 24-25 school year. **Fighting leads to immediate removal from the trip.**
- Any student who is assigned to Alternative Daily Assignment (ADA) during the first nine weeks of 25-26 school year or second semester of the 24-25 school year for **more than one** incident.
- Any student who has been suspended from Jackson Local Schools' busing.
- Any student who has excessive amounts of detention (lunch, after school, or extended Friday)
- Any student who has met the excessively absent or habitually truant for the current school year.
- Any student who still owes with regard to school fees.
- Students grades will be evaluated before trip and could result in removal from trip

In addition, there are several requirements that students' participation in the trip must meet that relate to physical stamina. All Students must be able to accomplish the following:

- 1. Function without direct adult supervision (for example: 8 hours in a hotel room at night)
- 2. Be aware of their surroundings and be responsible for their own safety
- 3. Communicate their needs to others
- 4. Follow oral instructions
- 5. Stay with an assigned group
- 6. Keep up with a moderate pace
- 7. Adapt to schedule changes and routine changes
- 8. Function on less than normal sleep
- 9. Be comfortable being away from home for an extended period of time

An administrator will meet with any student who faces the potential of non-participatory status. The parent/guardian will be notified of the final decision. <u>A decision made by the school for non-participation can occur any time up to the time of departure.</u>

VIOLATIONS OF THE STUDENT CODE OF CONDUCT ON THE TRIP WILL RESULT IN SCHOOL DISCIPLINE, UP TO AND INCLUDING IMMEDIATE REMOVAL FROM THE TRIP. THIS WOULD REQUIRE A PARENT TO DRIVE TO WASHINGTON, DC TO PICK UP THEIR CHILD.
