RESOLUTION

ESTABLISHING A SECOND CAPITAL PROJECTS FUND (USAS 070) FOR
THE PURPOSE OF ACCUMULATING RESOURCES FOR THE
ACQUISITION, CONSTRUCTION, OR IMPROVEMENT OF FIXED ASSETS
AND AUTHORIZING SPECIAL COST CENTERS THEREIN; AUTHORIZING
A TERMINATION BENEFITS FUND (USAS 035) FOR THE PURPOSE OF
PAYING TERMINATION BENEFITS OR PAYING SALARIES WHEN THE
NUMBER OF PAY PERIODS EXCEEDS THE USUAL AND CUSTOMARY
FOR A YEAR; AND AUTHORIZING TRANSFERS TO BOTH OF SUCH
FUNDS

(Ohio Revised Code Section 5705.13)

WHEREAS, pursuant to Ohio Revised Code Section 5705.13(C), the board of education of a school district may establish a capital projects fund for the purpose of accumulating resources for the acquisition, construction, or improvement of fixed assets of the school district;

WHEREAS, the Board desires to establish and maintain a second capital projects fund for the purpose of accumulating resources for the acquisition, construction, and/or improvement of fixed assets necessary to meet on-going and future capital needs of the School District as set forth hereinbelow;

WHEREAS, pursuant to Ohio Revised Code Section 5705.13(B), the board of education of a school district may establish a termination benefits fund for the purpose of paying termination benefits of its officers or employees or paying salaries when the number of pay periods exceeds the usual and customary for a year;

WHEREAS, the Board desires to establish and maintain a termination benefits fund for the purpose of paying termination benefits of its officers or employees or paying salaries when the number of pay periods exceeds the usual and customary for a year;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Jackson Local School District, Stark and Summit Counties, Ohio, that:

Section 1. The Board hereby establishes a second capital projects fund (the "Capital Projects Fund") to be used for the purpose of accumulating resources for the acquisition, construction, and/or improvement of fixed assets (within the meaning of Ohio Revised Code Section 5705.13(C)) necessary to meet the on-going future capital needs of the School District. The fixed assets that the Board intends to acquire, construct, and/or improve with the money to be accumulated in the Capital Projects Fund includes, but is not limited to, roofing, turf projects, HVAC and other projects, as further described on Exhibit A attached hereto (the "Project").

Section 2. The Treasurer is hereby authorized to establish such special cost centers within the Capital Projects Fund related to the Project as necessary to fulfill the intent of this Resolution. The Capital Projects Fund shall be funded over a maximum period of ten (10) years by: (1) transfers of School District funds for the Project; (2) donations from outside the School District for the Project; and (3) by transfers of other amounts from such funds and sources as the Board may determine from time to

time, which transfers by separate resolutions of the Board shall determine the amount of money to be accumulated for the aforementioned purposes.

Section 3. If the School District has not entered into a contract for the acquisition, construction, or improvement of fixed assets relating to the Capital Projects Fund during a period of ten (10) years after the date of initial establishment of such fund, then the Treasurer shall return such monies to the fund or funds from which they originated or to the fund that originally was intended to receive such monies.

Section 4. The Board hereby establishes a termination benefits fund (the "Termination Benefits Fund") to be used for the purpose of paying termination benefits of its officers or employees upon future termination or retirement or paying salaries when the number of pay periods exceeds the usual and

customary for a year (within the meaning of Ohio Revised Code Section 5705.13(B)).

Section 5. The Termination Benefits Fund shall be funded by transfers of School District funds for such payments. The Board hereby authorizes an initial transfer of \$1,200,000 from the General Fund to the Termination Benefits Fund. Additional transfers of other amounts from such funds and sources as the Board may determine from time to time may be approved by the Board by separate resolutions.

Section 6. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.

Exhibit A

Capital Projects Fund (USAS 070) – Project Description

Jackson Local School District

Stark and Summit Counties, Ohio

Pursuant to Section 1 of the Resolution adopted on May 19, 2025, by the Board of Education of the Jackson Local School District, the following items constitute the scope of work intended to be supported by the Capital Projects Fund (USAS 070). These projects are aligned with the goal of maintaining and improving the district's fixed assets in accordance with Ohio Revised Code Section 5705.13(C).

Capital Improvements Scope

1. Roofing Projects

- Replacement or major repair of roofing systems across district buildings
- Preventative maintenance and energy-efficiency upgrades
- Enhancements to improve structural integrity and reduce future repair costs

2. Turf Projects

- Replacement or resurfacing of artificial turf at district athletic fields
- Installation of updated drainage and base systems for safety and performance
- Enhancements to extend turf life and reduce maintenance

3. HVAC Upgrades

- Modernization and replacement of HVAC systems in school facilities
- Implementation of energy-efficient technology and control systems
- Improvements to indoor air quality and long-term utility cost savings

4. Gymnasium Updates

- Renovation of gymnasium flooring, bleachers, lighting, and related infrastructure
- Upgrades to accessibility and safety standards
- Enhancements to spectator seating, equipment, and user experience

5. School Buses

- Purchase of new school buses to replace aging fleet vehicles
- Acquisition of buses with improved fuel efficiency, safety features, and lower emissions
- Expansion of fleet capacity as needed to support student transportation needs

6. Additional Instructional Spaces

- Construction or renovation of classrooms and other learning spaces to accommodate enrollment growth
- Conversion of existing areas to flexible, modern instructional environments
- Infrastructure and technology upgrades to support curriculum delivery

The Jackson Local Schools Foundation has designed Jackson Polar Bear license plates that will be distributed by the BMV. The Foundation would like the District to receive the funds distributed by the BMV for the license plates. The District will briefly hold the funds in an agency account and distribute the funds to the foundation. The Foundation wants to use the District's accounts to ensure consistency of process and continuity of the program.

MEMORANDUM OF UNDERSTANDING

Between

Jackson Local School District ("District") and
Jackson Local Schools Foundation ("Foundation")

1) Purpose

This Memorandum of Understanding ("MOU") sets forth the terms and conditions under which the District will receive and promptly remit proceeds generated by the Jackson specialty license plates administered by the Ohio Bureau of Motor Vehicles ("BMV"). The Foundation has coordinated with the BMV to allow funds from these license plates to flow through the District on a purely custodial basis.

2) Definitions

License Plate Program: The specialty license plate bearing the Jackson logo or mark for which the BMV collects additional fees from purchasers.

Program Funds: All fees or monies the BMV sends to the District related to the License Plate Program. These funds are owned by the Foundation upon collection by the BMV.

BMV: The Ohio Bureau of Motor Vehicles, which collects fees for specialty plates and distributes them to designated recipients in accordance with state regulations.

3) Roles & Responsibilities

a. District Responsibilities

- The District will maintain a separate agency (custodial) fund called "Jackson License Plate Custodial Fund".

- ii. The District shall serve as the designated payee to receive Program Funds from the BMV.
- iii. The District shall remit all Program Funds in the agency fund to the Foundation quarterly or semi-annually depending on timing of BMV remittances.
- iv. The District shall verify and/or update the relevant contact information with the BMV by December 31 of each calendar year to maintain uninterrupted remittances. If the District fails to meet this requirement, liability shall be governed by the Limitation of Liability provisions in Section 8(d).
- v. The District will notify and provide supporting documentation to the Foundation once this annual verification is completed.
- vi. The District shall maintain accurate records of all deposits and transfers. Such records will be made available to the Foundation and any authorized auditor upon request.

b. Foundation Responsibilities

- i. i. The Foundation shall coordinate all necessary setup, documentation, and communication between the BMV and the District to ensure the Program Funds are directed to the District's agency fund.
- ii. The Foundation shall send monthly reminders to the District regarding the requirement to verify contact information with the BMV starting October 15th of each year until the District provides the required documentation. If the District has not yet completed the verification by December 1 5th. A representative of the Foundation should make every effort to contact the District office by phone call, in-person visit or any other means necessary in order to ensure that the verification process is done on time. The Foundation assumes all liability involved in failure to comply with the verification process. If, despite these efforts, verification does not occur, the District's liability is governed by Section 8(d).
- iii. The Foundation acknowledges it has full ownership and discretion over the Program Funds once transferred by the District.
- iv. The Foundation acknowledges that the District holds no responsibility or liability regarding how the Foundation uses these funds.
- v. The Foundation's expectation is that the only allowable expenditure from this agency fund is the full remittance of all Program Funds to the Foundation.
- vi. The Foundation is responsible for complying with all regulations governing charitable solicitations, specialty license plates, or other applicable laws.

4) Audit Rights

- a. The District's records for this agency fund may be subject to review or audit by the District's external auditors.
- b. Both parties agree to reasonably cooperate with any audit or financial review related to these transactions.

5) Term

- a. This MOU is effective on the date of the last signature and continues until terminated by either party.

6) Termination

- a. Either party may terminate this MOU with 90 days' written notice.
- b. Upon termination, the District shall transfer any remaining Program Funds in its custody to the Foundation within 90 days. The Foundation shall notify the BMV of any necessary changes in payee or remittance instructions.

7) Dispute Resolution

- a. Should any dispute arise under this MOU, the parties will first attempt in good faith to resolve the issue through direct discussion. If resolution cannot be reached, either party may seek formal mediation or arbitration upon mutual agreement, or pursue remedies in a court of competent jurisdiction.

8) General Provisions

- a. Amendments
 - i. This MOU may only be amended in writing, signed by authorized representatives of both parties.
- b. No Partnership
 - i. Nothing in this MOU constitutes a partnership, joint venture, or agency (other than the District's limited custodial role) between the parties.
- c. Entire Agreement
 - i. This MOU represents the entire agreement between the parties regarding the subject matter and supersedes any prior agreements or understandings, written or oral.
- d. Limitation of Liability
 - i. Verification Failure: The District shall not be liable for any direct, indirect, incidental, or consequential damages, losses, or claims arising from any delayed or missed remittances or the cessation of payments by the BMV.
 - ii. BMV Errors: The Foundation acknowledges and agrees that the District shall not be liable for any acts or omissions by the BMV, including but not limited to errors in processing, delayed remittances, or misdirected payments. The Foundation agrees to hold the District harmless from any losses, fees, or damages caused by BMV mistakes or delays.
 - iii. Foundation's Sole Responsibility for Use of Funds
Once transferred to the Foundation, all Program Funds are under the Foundation's exclusive control. The District expressly disclaims any liability arising from or relating to how the Foundation uses, invests, or disburses those funds.

MEMORANDUM OF UNDERSTANDING between
Jackson Township Board of Trustees and
Board of Education of the Jackson Local School District

1. Introduction

The Memorandum of Understanding (MOU) between the Jackson Township Board of Trustees (further known as the "Township") and the Board of Education of the Jackson Local School District (further known as the "School") sets forth the agreement of the parties and establishes the partnership, roles and responsibilities of the parties.

11. Purpose

The Township annually sponsors and host the Community Celebration. As part of the Community Celebration, the Township has contracted with a company certified to provide the Jackson Community a fireworks display on the Saturday night of the Community Celebration. The Township and School recognize the Community Celebration is an important community event. Likewise, the Township and School recognize the community has sponsored significant improvements to the boys' varsity baseball field, which is located close to the fireworks launch site. The Parties enter into this MOU for the primary purpose of identifying the insurance responsibilities in covering the artificial turf improvements in the event an expended firework shell should land on the artificial turf and causing damage to the field.

111. Responsibilities of the Parties

The Parties agree to perform the following activities and provide the following resources in support of insuring the artificial turn at the boys' varsity baseball field (artificial turf):

- a. The School: The School will maintain insurance coverage of the boys' varsity baseball field through Ohio Casualty and Liberty Mutual. Said coverage has a \$5,000.00, deductible. The School agrees to provide proof of the insurance and provide any additional documentation in order for Township to accomplish its responsibilities hereunder (Section III (b) and (c)).

- b. The Township: Will be responsible for obtaining additional insurance coverage that will cover a deductible of \$5,000.00, in the event a claim is made that is alleged to have occurred from the discharge of the Jackson Township Community Celebration's 5K barrage on Friday, June 20, 2025, and firework display on Saturday, June 21, 2025. Township shall name School as an additional insured and provide a certificate of insurance stating the same. Further, the Township agrees to undertake any additional reasonable safety precautions as recommended

by the Jackson Township Fire Chief. The Township is not required to insure any additional property, assets or contingencies of the School during the term the agreement is in effect.

IV. Period of Agreement

This MOU will become effective June 18, 2025. The MOU will terminate on June 22, 2025. Either party may terminate this MOU by providing a thirty (30) day written notice to the other party. In the event this MOU is terminated, the Township may still proceed with the 5K barrage on Friday, June 20, 2025, and fireworks display on June 21, 2025 at its own risk. This MOU is subject to the availability of insurance.

V. Sanctions for Non-compliance

Should the Participating Agency fail to fulfill any of its MOU duties in a timely manner, the party alleging non-compliance shall notify the other party in writing as to such deficiencies. Such notification shall be sent by certified mail, return receipt requested. The alleged non-compliant party shall have thirty (30) days to resolve such deficiencies, unless otherwise stated by the complaining party.


